

Harry & Rose Samson Family Jewish Community Center Scholarship Program

ABOUT

The JCC provides partial, need-based financial assistance for JCC Membership, Gan Ami Preschool, and Kids Center programs. Scholarships are awarded based on Adjusted Gross Income (AGI), household size, and documented financial circumstances. Funds are limited, and we aim to support as many families as possible.

Families of all backgrounds are encouraged to apply; individuals and families do not need to be Jewish to receive a scholarship or to participate in JCC programs.

Families only need to submit one scholarship application per calendar year. If applying for multiple programs, including camps, a separate application is not required.

REQUIRED DOCUMENTATION

Please submit the following with your application (REQUIRED):

- Most recent Federal 1040 tax return (first two pages)
- Schedule C (or F if self-employed)
- W-2s (or 1099s if the most recent return doesn't reflect current income)

If applicable, also include:

- Proof of Social Security, disability, unemployment, and/or state assistance
- Court orders related to custody or expense responsibility
- Explanation of significant changes in income since your last tax return
- Documentation of major medical expenses not covered by insurance

**Applications cannot be processed without required financial documentation*

SCHOLARSHIP POLICIES

- All past balances must be paid before a new scholarship can be awarded.
- Participation in JCC programs may not begin until the scholarship agreement has been signed & returned. If participation does begin, participants will be charged at full price, and funds will not be applied retroactively.
- Scholarships will not be applied without a signed agreement.
- Scholarships are not renewed automatically; a new application is required annually.
- If two households request scholarship, each household must complete a separate application when parents are divorced or separated.
- Minimum monthly payments are required.
- Applicants are responsible for all credit card processing and surcharge fees associated with their payment.
- Membership dues may change with 30-day notice.
- Scholarships apply to the original enrollment. Scholarship funds are not guaranteed if enrollment days increase after the school year has begun. Scholarships will adjust if enrollment days decrease.
- If circumstances change in employment, marital status, etc., please notify the Scholarship Administrator.
- All information is kept confidential.
